Nontraffic Violations
Effective 1/1/2011



If the defendant is charged with one or more of the offenses listed below, he /she may, if desired, enter a plea of guilty or no contest by utilization of a "Plea by Mail Form" (DCY 223), and upon payment of fines and costs listed, shall dispose the case without further court appearance.

Such plea shall be made at the first appearance, however, the defendant may be given a reasonable time within which which to make payment. Failure to make payment as agreed may result in the issuance of a **BENCH WARRANT** for **CONTEMPT OF COURT**

Exception: Skateboarding; Zoning Violations (Napoleon Township) - are municipal civil infractions infractions. The defendant may enter an admission of responsibility and pay the fines and costs listed below
